LOCAL NEWS

+The Missouri Catholic Conference has agreed to send speakers to educate us on Amendment 3. We will have a guest speaker on 23 August and another on 27 Sept after the 9:15 mass. Please learn more about A3 by attending these seminars .

+Linda Verlhurst of Missouri Right to Life will speak to our parish in October on Amendment 3. Dates to be confirmed.

+If you don't yet have a VOTE YES ON 3 car magnet, see me after .

+We have purchased 100 yard signs advocating VOTE YES ON 3 . See me to get one for your yard.

LEGAL NEWS

+VOTE YES ON AMENDMENT 3 on Nov 3 .

It rescinds the 2024 Amendment 3 which allows for abortions anytime for any reason.

It requires abortion clinics to meet medical standards for Health and Safety.

It insures parental consent for minors before aborting.

It bans gender mutilation for minors.

It reduces public funding for abortions.

It bars fetal organ harvesting .

It requires abortions to be only by a doctor.

+Amendment 4 failed to pass. So when A3 passes, some group will create another pro abortion citizen petition forthwith. An endless fight we will win.

+On 19 June a Judge Zhang arbitrarily ruled that all Mo abortion safeguards are unconstitutional 6 months after the Jan 2026 trial brought by Planned Parenthood . Six months to rule. Did money change hands?? Not surprisingly Planned Parenthood began doing abortions in Mo. WE NEED TO PASS A3.

On 10 July the Mo AG Katherine Hannaway filed an appeal to the Mo Supreme Court. The appeal asks to overturn the ruling, restore the laws, and the protections.

+Massachusetts passed a law on 30 July legalizing abortion at any time up to birth. The attending doctor makes the sole decision to choose life or death !

+On 17 July a Judge Wolf overturned the ban on Medicaid funded abortions in Pennsylvania. The PA AG Dave Sunday has appealed this ruling to their Supreme Court. The devil and Planned Parenthood don't stop!

+The Nov 3 Amendment 6 in Nevada proposes to allow abortions up to birth.

+LIFE NEWS

+On 24 July ; National ProLife Bridges day, ProLife volunteers held up large banners on highway bridge overpasses in 50 cities in the US. They proclaimed "ABORTION TAKES A HUMAN LIFE" 2 million cars drove under the bridges with the message.

+After 50 years of life the Hyde Amendment has saved over 2.6 Million lives.

+66 million babies have been killed by abortion in the US since Roe v Wade in 1973.

+NARAL abortion group is spending \$23 million this election cycle to convince voters aged 25 to 34 to vote for abortion minded candidates in Nov,2026. Planned Parenthood is spending \$47 million .

+A Gallup poll yielded a result that 49% of Americans say abortion is morally acceptable , down from 54%

+In June a Montreal ,Quebec, Canada suburb passed a resolution to grant TREES a formal right to life while fostering killing of babies by abortion.

+DC abortionist Cesare Santangelo has lost his medical license . He is famous for 3rd term abortions, allowing mothers to die after abortion complications, and the DC Five full term babies killed. His clinic is inoperable. Life Wins!

+The Little Sisters of the Poor , after 10 years of fighting and 3 Supreme Court victories against Obamacare mandate requiring insurance policy payment for abortion Now New Jersey and New York are Suing to strip them of their religious exemption. Oregon Right to Life just won a similar case.

+South Carolina abortions dropped 16 % in 1 year after the Heartbeat Law passed.

+Another abortion clinic has closed. This one in New Mexico .

+A new abortion clinic opened in bordertown Danville, Illinois serving Indiana abortion travelers.

+Planned Parenthood has closed another 3 abortion clinics in Michigan. Life Wins.!

+Planned Parenthood plans to increase abortion worldwide include:

- A. Put abortion funding into National budgets (domestic resource mobilization)
- B. Guarantee supply of abortion pills for anyone.
- C. Use taxpayer dollars to expand the abortion industry (Blended financing)
- D. Target the youth.

+Some ProChoice Catholics choose to agree with the Pro Choice “option” to kill an unborn baby. They claim the Bible doesn’t address children in the womb as human beings because they have been taught or believe it . This is flawed.

Luke 1:36 Gabriel tells Mary that Elizabeth conceived a son , not a potential son , a person.

Luke 1:43 Elizabeth declares Mary to be the “Mother of the Lord”

Genesis 25:22 Jacob and Esau , the twin “children in her womb , jostled with each other”

Judges 13:5 The boy Sampson is to be consecrated to God from the womb.

Etc,etc. There are dozens of verses defining the unborn as a person or child in the womb. We are all children of God, thus no need to impose another law not to kill us in the womb.

The Catholic Catechism is very clear . CCC 2270-2275. Human Life must be protected from conception . From conception a human must have the rights of a person, including the Right to Life. 2272 is very strong against abortion. Read it.

.+The Texas Republican convention in June named “Protect Life” as the top issue . The party platform includes : A oppose abortion pills B. Call on Trump DOJ to stop mailing pills and enforce Comstock. C. Support adoption D. Stop hospitals from withholding life saving treatment.

+A Father wrote a letter to his daughter.

CHEMICAL ABORTION NEWS

+325,000 abortion pills have been shipped to 25 states with abortion restrictions. Mailing abortion drugs is illegal since the Comstock Act of 1873 prohibits it. The US DOJ can enforce it, prosecute and sentence violators such as plan C. Josh Hawley has referred Plan C to the DOJ.

+63 % of abortions are by chemical pills

+Most of us don’t know about the worlds largest chemical abortion network known as DKT International. This monster sells to 100 countries. It claims non profit status. It is a huge pharmacy distributor, commercial importer, and a digital marketer. DKT has sold 189 million boxes of misopristol , 40 million mifepristone mail packs and 100,000+ manual vacuum devices to 3rd world countries. DKT funds abortion networks and stands up new abortion organizations in vulnerable countries. Who Knew ?

+Students for Life sponsored a study on mifepristone in the water supply. On 20 July the released results showed 3 cities sampled with levels 10 times higher than EPA contaminated levels. Austin , Tx , Blacksburg, Va and Carbondale , Illinois. These cities samples were super high in Mifepristone levels. Coincidentally these cities have high chemical abortion rates. Mifepristone is being flushed.. Water treatment plants do not and can not easily filter out mifepristone. Human impacts include infertility, pregnancy issues , fetal mis-development, miscarriage, bone loss, erectile dysfunction, obesity, etc. Students for Life are pushing the EPA to add mifepristone to its contaminated list for enforcement.

+70% of voters agree to reinstate the original FDA in person dispensing of abortion drugs.

+On 16 July 2 US Senators sent a letter to AG Todd Blanche. The request was to enforce a lower court ruling ending the Biden policy of no in person doctor visits and dispensing of abortion drugs , even while the FDA Safety Review plays out.

+ A Federal Judge has blocked the new law in South Dakota that bans advertising of abortion pills. Mayday Health of New York , who sells the adverts, has sued So. Dakota AG and Governor for “free speech violation.” Stay tuned.
