LOCAL NEWS

+Bottles for Life Campaign- our fundraiser continues. Your donations are generous and help our cause - Saving Unborn Babies. Thanks to those who have already donated.

+Our Shiloh Center has a new Director. Her name is Courtney Gilmore. We are going to be privileged to have her speak to the Ladies Auxiliary. Pull up the Clara Center webpage and view her introductory video.

+The Knights and Ladies Auxiliary have volunteered to work on a rehab project at the new Shiloh location. Stay tuned as we will need help with heavy lifting , painting and cleanup.

LEGAL NEWS

+The Missouri Assembly passed HR 73 putting an Amendment 3 on the Nov 2026 ballot to repeal 2024 Amendment 3. After Sec of State Hoskins submitted 2 versions of the language, the circuit court approved and certified the language. As expected, the devils agent Anna Fritz-James sued to change the language. The Western District Appeals Court unilaterally revised the text to say "Repeal the 2024 voter approved amendment

Our fight remains ahead in 2026.

+The 10 Nov deal to reopen the government rejected abortion funding for the current Obamacare ACA insurance program. Pray that our House/Senate members stand firm and reject taxpayers paying for abortions in any way.

+Wisconsin has passed a law declaring to all who question it, that miscarriage is NOT an abortion.

+A group of prolife US Senators have sponsored the "Conscience Protections for Medical Residents Act. It will shield students from forced abortion training.

+In April 2023 N.Dakota passed a bill that protects the unborn thru birth. An exception for risk to mother was in it. In July 2023 a clinic sued to stop the law's effect. In Oct 2023 a judge struck down the law. In Nov 2024 N. Dakota appealed to the State Supreme Court. On 21 Nov 2025 that court upheld the abortion ban. Life Wins !

+Nevada has passed a bill that creates a state Health Care Grant Program of \$60 million. Planned Parenthood doesn't meet the grant requirements. 'Money must not be expended for any abortion'. Nevada Right to Life helped the Governor to include language to focus on health care providers shortage, not abortion. Listen up Missouri.

+The Florida AG has filed a suit against Planned Parenthood(PP) for false advertising . PP advertises that chemical abortion pills are 'extremely' safe. Florida alleges that PP grossly misrepresents the risks of abortion drugs in its website, brochures, TV ads, etc. Stay tuned Missouri.

+On 6 Nov Nebraska Gov Pillen signed an order directing that Medicaid and any public funds WILL NOT be given to clinics that perform or promote abortions. Planned Parenthood (PP) was specifically called out. Any facility found to provide abortions will be defunded. PP will lose \$341,000 .

+On 13 Nov Pres Trump signed an Executive Order to add resources for fostering children. Democrat states are refusing parents to foster children unless the parents agree to pay for the child's gender identity test, actively seek trans child mutilation, not talk about Christian religious views, etc. The EO directs HHS to work with the White House Faith Office to take action to override these draconian road blocks and to serve foster families.

+The Ohio House of Representatives has passed two prolife bills. 1. HB 324 prohibits mail order sale of mifepristone and declares it to be a dangerous drug. Thus a women must in person see a doctor to be informed of the side effects. 2.HB 485 requires public schools to provide education on human growth period, including an ultrasound video and viewing "Meet Baby Olivia" video. In my view Missouri should do the same bills.

+A conviction of a Florida Pregnancy Center vandal was upheld by the 11th -2- Circuit Appeals Court. The ruling provides a model for prosecuting hundreds of pregnancy center and church vandals since the Dobbs decision. Accountability has begun. The Fla vandal got 120 days in jail and \$13,000 in fines. Lets go !

LIFE NEWS

+November was National Adoption Month. Dream big, Choose Adoption. Pull up the U Tube video "This Time" by John Elefante. It tells the story of his adopted daughter Sami's rescue from abortion. Worth It.

+Planned Parenthood has now permanently closed its 48th abortion clinic this year. Last 2 were in Ohio and Wisconsin. Closure due to defunding. Life Wins !

+The National Institute of Health has cancelled dozens of human fetal research projects started by Biden and Fauci. These included those at Univ of Pittsburgh. U of P has paid Planned Parenthood for aborted fetal tissue for years, including from partial birth abortions. No More. Thank God.

+Susan B Anthony and Women Speak Out PAC have announced they will spend \$80 million in 2026 Midterm elections. Their purpose is to retain and add prolife majorities in Congress. The plan is to reach 10.5 million voters via digital ads , emails, and thru campaign canvassing, visits to 4.5 million homes. They will send students in get out the vote campaigns. The focus will be in key states with close Senate and House races.

+A ProLife coalition is working to prevent Planned Parenthood from regaining full funding again on 4 July,2026. The coalition includes Live Action, Students for Life, Catholic Vote, National Right to Life, SBA, and prolife congressional staffers. Pray for their success and for a permanent defund. Message your Reps.

+Archbishop of Oklahoma City Paul Coakley has been elected President of the US Conf of Catholic Bishops. His platform is to place abortion legal protections at the center of Catholic engagement.

+Florida rescued 122 trafficked children. The AG will seek the death penalty against the child predators for child sex battery. It is time for all states to follow this model. Missouri ??

+Vote Yes on 2026 Amendment 3.

+ 40% of premie babies born at 22 weeks survive. 100% of aborted ones die.

+Pregnancy Centers provided \$452 million in medical care, support and education services and material help in 2024. The centers saw over 1 million clients, 1 per day. Over 10,000 professionals and volunteers staff the centers. 29% provided Abortion Pill Reversal. The centers walk alongside women, men and families to help them choose life. Support our Pregnancy Center. !!

+Whitehouse Director of Media Affairs Sonny Nelson was almost aborted. Her mother chose life. Before working at the White House Sonny worked at Hope Pregnancy Center. Her mother Tonya Nelson has dedicated her life to be the founder and CEO of 3 Hope Pregnancy Centers for 29 years in North Carolina. Life trumps apathy !

+On 20 Nov the United States Dept of State declared abortion to be a human rights violation. A directive was sent to all US Embassies Worldwide requiring reporting of countries compelling citizens to pay for abortions or abortion drugs. Thus they lose credibility as a human rights leader. Those who allow abortions will eventually face defunding of US foreign aid money.

+ A new multistate fund, Palmetto State gives money to Planned Parenthood to use to secretly transport minor girls and pay for an abortion. A video from Myrtle Beach Mall shows a girl picked up and being driven 2 hours to Planned Parenthood against her parents approval. A prolife group Survivors of Abortion Holocaust, discovered this fund and took the video. Palmetto aids minors w/o parents consent, sells mail order abortion pills to teens and hides all of it. Please watch out for young pregnant girls who may get caught in this vile operation.

+22 Senators, led by Mike Lee and Chris Smith have called out the US Office of Personell Management. They sent a letter demanding that OPM stop illegally underwriting taxpayer funded health care plans for Congress and their staff to cover abortions. The 1984 Smith Amendment barred taxpayer funds from paying for abortions or “administrative health expenses” on expense reports.

CHEMICAL ABORTION NEWS

+On Nov 5 Dr Hassan Abbas was delicensed by the Ohio Medical Board. He poisoned his pregnant girlfriend with mifepristone after ordering it online using his divorced wife's name without consent. He will also be fined \$20,000.

+Nurse Jessica Williams was pressed by her husband to take mifepristone at 9 weeks. She did so as he watched. No doctor or ultrasound, just online pills. She turned to a Las Vegas pregnancy center who gave her an ultrasound and then abortion pill reversal progesterone. The baby survived. Jessica was given spiritual support, parenting classes and practical material support. Our Shiloh and Clara Centers offer these services to mothers in need for free.

+Mo AG Catherine Hanaway has filed a lawsuit in federal court to roll back the Sep 2025 FDA decision to approve a new generic mifepristone. Basis of the suit is no medical safeguards. The suit asks the court to block the new drug, to restore pre 2016 safety standards, enjoin mail order distribution and stop manufacturers from violating ProLife State Laws.

+On 20 Nov, 175 members of Congress , including leadership sent a letter to Secretary Kennedy and FDA head Dr Makary. The letter again asks for an aggressive investigation and review of the lax safety standards of mifepristone. The letter demands immediate in person doctor only dispensing. The letter asked for elimination of online dispensing of the pill sets. Pray that it stops.
