### LOCAL NEWS

### LEGAL NEWS

+For 10 days a trial in Jackson County heard testimony on the issue of Missouri's abortion safety regulations. Mo AG and numerous witnesses maintained that the regulations have been proven necessary. Planned Parenthood attorneys opined on how abortion clinics were hamstrung by being forced to provide informed consent, 72 hour wait period, have a facility medical license, do a pelvic exam, etc. Killing life is hard isn't it? They used the failed argument that 2024 A3 eliminated the statutes being litigated. What a farce. Both parties briefs are due 10 April. Pray !

+Planned Parenthood(PP) filed a suit challenging the defunding of abortionists via the Big Beautiful Bill. On 30Jan PP voluntarily dropped the suit. This follows the US First Circuit ruling against Calif vs HHS. This is a good step , however proliferators must find a way to make the defunding permanent. If not, 600 PP clinics will again make insurance claims to Medicaid for abortion services on 5July 2026.

+On 23 Jan the Mo Supreme Court overturned Senate Bill 22 as unconstitutional. The law allowed the Mo AG to appeal temporary blocks to state law. It also changed the ballot language review process to stop a judge from changing ballot language w/o the Sec of State or Mo General Assembly approval. Recall that 2026 Amendment 3 went thru 2 judge ordered rewrites of the approved language. Legislating from bench.

+On 6 Feb the Mo House passed HB1667 which ensures that babies born alive after the attempted abortion receive the same care as a natural born baby. The Senate bill 999 moves to a vote soon.

+On 6 Feb Texas legislature passed the Woman and Child Protection Act. The law allows citizens to sue companies and activists who break Texas law by killing unborn babies, even out of state; lets women harmed sue traffickers; and helps ProLifers stop abortion activists in other states. Penalty is \$100k per violation. Mothers and medical providers are protected. The bill only functions if the existing Comstock Act is enforced nationally.

+Texas AG Paxton has sued Debra Lynch of Delaware Safe Harbor, a mail order abortionist. She sends 162 pill sets per week (8500/yr) to Texas. She is not a Texas licensed doctor. The suit calls out her violation of the Human Life Protection Act. She also violates Texas law by practicing medicine w/o a license. Penalties are civil and \$100k per violation. Stay tuned.

+On 21 Jan the US House passed the Supporting Pregnant and Parenting Women Act. It protects 2700 pregnancy centers and assures that they get block grants from states to help provide free medical tests, materials, APRN referrals, spiritual services counseling ,etc. A mother testified who had been sexually trafficked in 33 states, connected with a Pregnancy Center, saved her baby, got a degree and ultimately became the Executive Director in a Vermont pregnancy center.

+Virginia has an amendment on their 3 Nov ballot to enshrine unlimited abortion at any time at any mother's age. It would rescind all current protections.

+On 28Jan a lawsuit filed in Arkansas seeks to strike down all of the state's pro life laws and abortion restrictions. An OBGYN whines that the save mother exception is "unworkable and unconstitutional" . Arkansas Right to Life polled OBGYNs. Not one has feared legal suits. Not one has recommended an abortion vs early delivery of the child. Arkansas is the most prolife state for 6 years. Life will win.

## LIFE NEWS

+On 28 Jan 1900 Kansas students, grade 7-12 attended the Kansas March for Life. They marched to the Capitol and visited prolife and pregnancy center booths. They honored 19,800 babies aborted in 2024. There is Hope.

+On 22 Jan the Trump HHS team announced that the National Institute of Health( Fauci) will NO LONGER FUND ANY RESEARCH involving fetal tissue from aborted babies. Planned Parenthood had sold tissue to Univ of Pittsburg and UC San Diego since 2015. No More. Alleluia!

+On Jan 21-23 the Trump Life Administration achieved the following :

- Department of State expanded Mexico City Policy to ban US foreign aid money from going to abortions.

- The NIH will not fund any research on human fetal tissue.

- The SBA will claw back from Planned Parenthood \$88 million in illegal Paycheck Protection covid loans. A fraud investigation of PP is in play.

- HHS Office of Civil Rights (OCR) served notice of violation to Illinois of a law that forces medical providers to refer patients to abortionists despite religious objections.

- +HHS OCR rescinded 3 Biden era"rules" that violate federal consensus protection statutes for churches and medical providers.

+ On 2 Feb the HHS issued a notice removing Biden's policy. Pharmacies are now NOT REQUIRED to sell abortion drugs.

+A Gallup poll on 28 Jan revealed that for ages 18-29 those who chose "ProLife" increased 11% to 37%.

+In Florida 9 abortion clinics closed and as a result abortions are down by 45%. Florida is third in the nation behind California and New York in numbers of abortion clinics.

## CHEMICAL ABORTION NEWS

+On 30 Jan Senate ProLife Chair Cindy Hyde Smith introduced the SAVE Moms and Babies Act, The legislation would reinstate in person dispensing of abortion pills by a doctor and prohibits mail order distribution and telemed internet prescriptions. This prioritizes mothers and babies over the profit minded purveyors of the abortion pill international business. Mifepristone pill sets cause >63% of all abortions and must be shutdown in law. Congressmen Alford ?? How about a House bill ?

+Planned Parenthood will now mail out abortion pills for \$52 to anyone. No checks on medical issues, gestation age. No counsel. No follow up. PP is a drug dispensary.

+200 women call Abortion Pill Rescue Network every month and do abortion pill reversal 6 per day.

+Ohio is the first state to propose the "Apple Act". It is a model to hold Pill providers liable. As states adopt it it will inform users of the right to sue prescribers, distributors, manufacturer's ,or seller if anything goes wrong.. Listen up Missouri.

+Abortion drugs , via the mail , are killing more Americans than Fentanyl, cocaine or heroin combined. 1 in 4 abortions are due to abortion by mail. 150 women per day are being seriously harmed.

+A 911 dispatcher has shared 1 week of panic calls from women/girls in chemical abortion trouble:

~How much blood loss is normal?

~How far along am I ? Is the baby alive ?

~If I drink rubbing alcohol will my baby die? Will I ? My boyfriend says no .

~Should I take online abortion pills ?

~ I am 6 weeks pregnant. Is it safe to take abortion pills ? (a 2 am call )

~Is 2 pills enough ?

~ Is there a chemical abortion medical hotline? I am bleeding out.

~Can I say it is a miscarriage at the ER ?
