

JULY 2026 LIFE REPORT

LOCAL NEWS

+The Missouri Catholic Conference has agreed to send speakers to educate us on Amendment 3. We will have a guest speaker on 23 August and another on 27 Sept after the 9:15 mass. Please learn more about A3 by attending these seminars .

+We are working with the Missouri Right to Life and our local printer to purchase 100 Yes on 3 yard signs. ~ \$5 each with shipping. The signs will look like the handout attached. The officers agreed to the plan.

+On 27/28 June the Knights passed out Vote Yes on 3 magnets with a list of 10 reasons to Vote Yes on A3. If you didn't get one see John Cunningham or Darrell Leis.

+The parking lot road side Shiloh banner needs replaced. If you have ideas for a new Shiloh/Clara 4x8 ft banner , please get them to me.

LEGAL NEWS

+VOTE YES ON AMENDMENT 3 on Nov 3 .

It rescinds the 2024 Amendment 3 which allows for abortions anytime for any reason.

It requires abortion clinics to meet medical standards for Health and Safety.

It insures parental consent for minors before aborting.

It bans gender mutilation for minors.

It reduces public funding for abortions.

It bars fetal organ harvesting .

It requires abortions to be only by a doctor.

+VOTE YES ON AMENDMENT 4 on August 4 .

After Amendment 3 passes the pro abortion lobby will immediately start a citizen initiative (not legislative) to remove the 2026 Amendment 3. Amendment 4 :

Will modify current law that says initiative petitions only require a statewide majority to pass.

Will require a majority of voters in Each of the 8 Mo Congressional Districts to approve a petition to amend the Mo Constitution , thus avoiding Kansas City, St.Louis , Columbia and Springfield overwhelming the rest of the state voters.

Will put the full text of the petition on the actual ballot.

+On 19 June a Judge Zhang arbitrarily ruled that all Mo abortion safeguards are unconstitutional 6 months after the Jan 2026 trial brought by Planned Parenthood . Six months to rule. Did money change hands?? Not surprisingly Planned Parenthood began doing abortions in Mo. WE NEED TO PASS A3.

+On 11 June Senator Josh Hawley pressed US AG Todd Blanche to settle the continuing lawsuit against the FDA to halt mail order chemical abortions. His letter also asked for an investigation of Planned Parenthood for distribution of gender trans hormones to minors while receiving Medicaid payments illegally.

+On 24 June the Senate ProLife Caucus introduced the Dismemberment Abortion Ban Act of 2026. The law would federally ban dilation and evacuation procedures. Doctors who do this will be fined and go to jail for 2 years after criminal charges , which puts their license in doubt. Our society cannot allow this barbaric practice.

LIFE NEWS

+ Arkansas is placing a Monument to the Unborn on its state capital grounds. The monument recognizes the 236,000 unborn babies killed in abortion from 1973 to 2022.

+ From July 2023 to June 2024 1.1 million babies were aborted in the US. 1.6% over 2023. 63% by abortion pill poisoning , 20% by telehealth mailings.

+On 5 July \$750 million began flowing to Planned Parenthood via federal grants to states to pay for Medicaid abortions. Call/write your 2 US Senators asking for defunding.

+4 years after the Dobbs June 2022 ruling ,20 states have laws protecting babies from abortion. 30 don't.

+In 2026 10 Planned Parenthood clinics have closed. 4 states have zero Planned Parenthood locations.

+The US Health and Human Services notified 50 groups , Including Planned Parenthood , that they will no longer receive teen pregnancy prevention grants. These groups push sexually explicit content not suitable for teens (or anyone) . The curriculum taught are too disgusting to report here. HHS terminated \$67 million in grants , 53 of 67 were from the Biden Administration. LIFE WINS !

CHEMICAL NEWS

+Mo AG Hanaway and 13 other states AGs wrote a demand letter to the EPA pointing out the danger of tons of the steroid mifepristone dumped into our waterways. Water plants don't treat to remove mifepristone. The letter asks that the EPA add it to the list of harmful contaminants and enforce its ban.

+On 23 June a coalition of 83 State/national prolife groups sent a letter to AG Todd Blanche advocating for the DOJ to resolve Louisiana vs FDA . The DOJ just has to follow a court ordered decree to stop abortion by mail while the FDA slow walks the "safety review" . In ProLife States 15,000 babies per month die from abortion pills. It should be clearly noted that the 5th Circuit Appeals Court granted an immediate halt to mailing mifepristone. The Supreme Court then stayed the order until LA vs FDA is litigated.

+ The use of misopristol without mifepristone to quickly expel a live baby is NOT approved by the FDA.

+Out of state abortion companies are sending 15,000 pills per month into states with ProLife laws. This resulted in 330,000 babies killed by abortion pills. Why? Because the DOJ hasn't penetrated the shield laws protecting the purveyors of abortion by mail. Interstate mail order abortion that violates the individual states laws must be dealt with by the DOJ . The original FDA rules can be reinstated by the FDA officials.

+On 9 June Alabama AG Marshall sent cease and desist letters to 6 abortion pill businesses ordering them to cease advertising and mailing pills into Alabama. Alabama law bans the poison pills.

+On 1 May Iowa Gov Reynolds signed HB 2788 . It mandates that abortion poison pills be dispensed in person by a doctor. The bill outlaws mail order and telehealth distribution . Good Work Iowa.!

+ "Because someone answered at 2 am, I got to be a mom" Abortion Pill Reversal works if done in time.

+On 12 June Wyoming pro abortion judge Campbell struck down 3 prolife laws passed in 2025. They are:
Abortion clinics must be licensed.

Ultrasound and 48 hr waiting period before an abortion.

Limits on abortion pills use or prescriptions.
