

JUNE 2026 LIFE REPORT

LOCAL NEWS

+Shiloh Walk for Life received donations exceeding the goal of \$50,000. Thanks to all Knights/Ladies/parishoners who made the walk a success. We will keep saving babies!!

+ We have received and presented a \$400 check to Shiloh as a 20% bonus from Supreme for our donations to Shiloh Pregnancy Center.

+Be prepared to attend teaching seminars on the Life preserving November Amendment 3 ballot. We plan to have guest speakers in each of August, September, October months.

LEGAL NEWS

+Governor Kehoe has decided to place the 2026 Amendment 3 on abortion restrictions onto the Nov 2026 ballot.

+VOTE YES ON AMENDMENT 3 . See the attached flyer which lists 10 reasons to Vote Yes. Spread the word and get educated. (presenter walk thru it)

+The ACLU has received \$2.5 million from illegal foreign donations and is using it to fight the 2026 Amendment 3 . The foreign donations are being laundered into the 2026 A3 campaign. The Americans for Public Trust filed a legal complaint with the Mo AG's office. Mo has banned foreign money into ballot measures. The ACLU has made 3 contributions to 'Stop the Bans'.

+On 15 May the Mo legislature passed the 'Born Alive Abortion Survivors Act'. These babies are due the same care as any other person from Medical Professionals. Life Wins !

+On 1 June Rep Cammock of Fla and 15 other reps/senators introduced the "Dismemberment Abortion Ban Act of 2026 . It bans dilation and evacuation dismemberment methods which are the most common 2nd and 3rd trimester surgical abortions. 60,000 to 70,000 babies are killed this way every year.

+In May the Indiana Supreme Court rejected Planned Parenthood's legal challenge to the state's abortion ban. Life Wins !

+California sued Anastasia Rogers, under the California Face Act. She was sued for posting a 13 second video of a Planned Parenthood 'escort' who told 'clients' to "unlive them". She asked 'is this legal?' She won the case in a 10-2 not guilty mistrial. Life Wins !

+US Circuit Judge Duncan has ruled against Planned Parenthoods (PP) attempt to dismiss a false advertising suit on the risks of abortion pills. Florida's AG says PP is violating Deceptive and Unfair Trade

Practices law by falsely claiming that abortion drugs are "safer than Tylenol" . The AG seeks \$350 million.

LIFE NEWS

+ Moms.gov is a federal resource website. Check it out. It was launched in May by our HHS to support pregnant mothers and new mothers. It connects mothers to pregnancy centers, adoption resources, child healthcare, TrumpRx, Trump Savings Accounts and other resources.

+ The ProChoice Guttmacher institute estimated 100,000 abortions occurred in Jan 2026 after 99,470 were reported. This doesn't count the unreported chemical abortions. We have to get the Comstock Act enforced to stop mailing of abortion poison pills.

+Drake Middle School, in Colorado barred a 13 yr old 7th grader from reading her prolife poem in class. The assignment was to write about a world issue she is passionate about. She chose abortion . Her poem has biblical verses, Dr. Seuss, and stats on abortion. The school claimed the poem was offensive and caused students to feel unsafe yet they allowed other poems on 2nd amendment, Jesus mocking, and LBGTQ rights. So she gave the poem on a TikTok interview. The girls grandmother became pregnant at age 14 and chose life, thus the girl's thriving family exists now.

+FDA director Marty Makary and 3 hi level FDA officials resigned or were fired in May. Directors of Drug Evaluation and Biologic Evaluation left the FDA. All this is due to HHS orders to complete the study of mifepristone ASAP and ultimately remove it from the market and stop illegal distribution.

+On 20 May at the Missouri Right to Life " Make Missouri ProLife Again" banquet Riley Gaines gave a passionate defense of women, children and Truth. The message to 1000 people was to defeat unlimited abortion and Vote Yes on 3. MRL raised \$1.5 million for the Vote Yes on 3 campaign.

+A Safe Haven Baby Box will be installed at the Lake Ozark Fire Dept at Bagnell Dam. The OSAGE Nation funded the \$ 17,000 unit.

CHEMICAL ABORTION NEWS

+On 14 May the SCOTUS sent back to the 5th circuit of Appeals the issue of allowing abortion pills to be mail distributed w/o an in person doctor visit. The FDA study results are being slow walked. The Louisiana court case challenging baby poison sent by mail as violating La law. The suit is La vs FDA. Stay tuned.

+Colorado Gov Polis signed a bill on 29 May forcing Colorado Public Colleges to stock and sell baby poison to students . Go figure.

+New York abortionist Margaret Carpenter ships baby poison kits interstate. She has been indicted by Louisiana AG Merrill. A La grand jury issued a warrant for her arrest. She has fled to Dublin, Ireland to avoid arrest. This is a big deal.

+

+ So Dakota will ban advertising of abortion pills in July, based on a bill signed in March. The bill places a penalty of 2 years in prison on advertisers. Non profit MayDay Company sued So Dakota in the past and lost. They have again sued on 29 May using the same argument as the past loss. Judge shopping .

+Iowa's Gov has signed a bill banning distribution of abortion drugs thru the mail. The bill also requires abortionists to do an inperson exam b4 prescribing abortion pills. Life Wins !

+Oklahoma has a new bill making it a felony to traffic abortion pills . Missouri ? Life Wins !

+The Abortion businesses are using Plan C .org which is an online directory for sellers/purchasers of abortion poison mifepristone/misopristol. The organizations are violating state/federal laws as follows:

8 online sellers ship to states with bans on abortion

15 of 79 sellers observe the FDA limit of 10 weeks gestation.

81% mail the poison pills w/o knowing gestation age of the baby.

18 foreign websites don't ask for any i.d. information and sell to anyone.

After Dr Francis, an OBGYN provided medical conditions in her purchase that grossly disqualified the sale, she still received the pills no questions asked.

100% sold to minors w/o any interrogation or control.

+In late May PP launched a revenue program selling abortion pills to women not pregnant for the purpose of stockpiling pills for future abortions . PP charges \$150 per kit.
