

# MARCH 2026 LIFE REPORT

## LOCAL NEWS

+SHILOH Center Open House- on 31 March Tuesday from 6-8pm will be a special open house for the Knights and Auxiliary Ladies. The public open house will be on 1 April from 5-8pm. Fr Dan will join us.

+ 40 Days for Life – thanks to the Prayer Warriors who stood in the cold rain on 3 Mar 26 at the OP Abortion shop. It was clear that the mothers are going in , picking up abortion pills, and leaving all in 5-7 minutes.

## LEGAL NEWS

+VOTE YES ON AMENDMENT 3 . It requires abortion clinics to meet medical standard for Health , Safety and cleanliness. It ensures parental consent for minors before aborting. It bans gender mutilation for minors . It reduces public funding for abortions.

+ The 2026 Mo Assembly ProLife bills in process include:

\*HB3146 modifies provisions of ballot summary language to send the Sec of State language, when

Challenged, back to the Secretary 3 times if needed. It forbids a court judge from rewriting it. It allows 100 words vs 50 to describe the ballot issue.

\*SB978 will require teaching human development curriculum (videos) in public schools.

\*The Born Alive Survivors Protection Act is moving thru the House & Senate.

+On 4March the November 2026 Amendment 4 language was revised by a Circuit Judge Green . A4 language , as passed in 2025 would require penalties for foreign source donations and fraud in the petition signatures. Green removed this language and rewrote it to retain these entries:

\*A4 will modify current law that says initiative petitions only require a statewide majority to pass.

\*A4 will require a majority of voters in EACH of the 8 Mo Congressional Districts to approve a petition to amend the Mo constitution.

\*A4 will put the full text of the petition on the ballot.

+On 6 March an Indiana judge ruled that there is a religious right to kill babies by abortion. On Appeal.

+On 6 March Oregon passed a bill to force the Oregon Health Authority to fund Oregon Planned Parenthood permanently using taxpayer dollars. \$87.5 million . People will pay an “abortion tax”

+Wyoming Senate fell one vote short of placing a ProLife Constitutional Amendment on the 2026 ballot.

+A bill is moving thru the Florida Senate that allows parents to sue for wrongful death of their baby, after medical negligence or 3<sup>rd</sup> party negligence as in drunk driver. The bill defines an “unborn child” as a Homo Sapien, at any stage, who is in the womb ! The bill excludes mothers and doctors who offer standard care.

## LIFE NEWS

+Tim Tebow was almost aborted until his parents overrode the doctors and chose life.

+A Knights/Marist poll produced the following results:

- \*84 % support pregnancy resource centers

- \*62% identified as ProChoice adults

- \*54 % oppose using tax dollars to pay for an abortion

- \*59 % think an in person visit with a doctor should be required for a chemical abortion pill.

- \*88 % contend it is possible to have laws that protect the mother and the unborn.

+Planned Parenthood (PP) is cash poor since 4 July 2025 . To fill the gap their clinics are now selling/applying lower cost Botox injections and laser hair removal. Protect your children and grandchildren. PP is actively pushing for teens, school sex education programs, and sex videos, indoctrinating teens as future clients. PP passes out free birth control , hormones and even abortions to teens.

+July 5,2026 will be the day PP will restart insurance claims for abortion into Medicaid. The defunding must be made permanent. Contact your representatives .

+On 26 Feb the European Union declared that EU members can use money from an existing EU Social

Fund . The money can be used to pay for women who live under ProLife laws to get free abortions. So proabortion women can travel within EU countries, all expenses paid to kill their baby for no cost. I ask you, are we evolving to this same level of barbaric society and lack of morals.?

+ Listen Up. I asked Google AI “ Does an abortion kill an unborn human baby ?” The answer had 4 points.

1. Abortion is the deliberate termination of a human pregnancy which results in the death of the fetus. There is debate on whether the fetus is an unborn human baby.
2. ProLife proponents assert that life begins at conception , a fetus is a human being , abortion is killing a human baby and is wrong.

## CHEMICAL ABORTION NEWS

+The state of Washington is now distributing (\$2.1 million) millions of abortion pills. These pills are being given to abortion clinics to redistribute without any controls or restrictions. These pills were ordered by ex Gov Inslee after the 2023 Dobbs decision.

+ As of 16 Feb Heartbeat International has shown that 8000 lives have been saved through the Abortion Pill Rescue Network (APRN) There are 1500 doctors, pregnancy centers and hospitals who are in the APRN Network. The APRN takes 200 calls per month from anguished mothers after taking the pill.

+ The State of Louisiana is suing the FDA challenging the decision to abandon the in-person dispensing and allowing interstate pill mailing without screening or exam. The Ethics and Public Center (EPPC) has released a new study that shows the FDA no visit, no exam protocol proves out to cause serious adverse events to be 1.5 to 2.3 times what it was with the in- person visit. Stay tuned, this suit is a big deal.

+Texas AG Paxton has sued Aid Access and its operators for internationally shipping abortion drugs into Texas in violation of Texas law. Kentucky already has HB 646 which provides felony penalty for trafficking pharmaceuticals intended to terminate life.

+West Virginia Senate passed the "Anti-Chemical Abortion Pill Trafficking Act. The law would impose criminal and civil penalties on pill vendors prescribing and shipping pills into West Virginia. 10 years or \$10,000 Missouri ??

+The University of Oregon is now passing out free abortion pills to students with no controls.
