LOCAL NEWS

+Midwest March for Life- thanks to those who attended. We were given ideas for getting voters out to Vote YES on Nov 26 Amendment 3 . Please educate yourself about A3 and A4.

+Shiloh Walk for Life- is on 16 May at the Harrisonville City Park at 0830 am. Get sponsor forms at the walk or at Shiloh. If you have donated in the past you will get a mailer . The Knights will donate \$1000 from the Baby Bottle funds. Join us to support the Shiloh/Clara Centers and to pray for the unborn.

LEGAL NEWS

+VOTE YES ON AMENDMENT 3 . It requires abortion clinics to meet medical standard for Health , Safety and cleanliness. It ensures parental consent for minors before aborting. It bans gender mutilation for minors . It reduces public funding for abortions. See flyer with this report.

+A St Louis University poll shows that 12% of Mo voters are unsure about supporting Amendment 3 . We have work to do. It is time to do door knocking , post cards, fone calls, bulletins, and speakers.

+Vote Yes on Amendment 4-

*A4 will modify current law that says initiative petitions only require a statewide majority to pass.

*A4 will require a majority of voters in EACH of the 8 Mo Congressional Districts to approve a petition to amend the Mo constitution.

*A4 will put the full text of the petition on the ballot.

+BEWARE . There are petition signature collectors (shady ones) circulating a petition to put an amendment on the Nov '26 ballot. The language, in summary, says that if a law is on the books, it cant be repealed without draconian requirements met. The abortion lobby is trying to defend against the Nov 26 Amendment 3. I saw an agent with the petition telling a lady that the petition would benefit the schools. BEWARE DON'T SIGN IT.

+ A Jackson Co Judge Zhang received briefs on the removal of Mo Abortion Safety Regulations trial of Jan 26. The April 10 briefs are to be ruled on before the vote on A3 , likely in June.

+On 29 Apr the US Scotus ruled that state governments can not use their departments to bully and intimidate ProLife Ministries. The case was First Choice vs New Jersey. The state demanded records and donor information. No complaints on First Choice were received yet NJ AG created a "Reproductive Rights Strike Force" and sent a subpoena for private records . Life Wins !

+Mississippi Gov Tate Reeves signed HB 1613. It makes it illegal to create, sell, barter, transfer, manufacture, distribute, dispense or prescribe an abortion inducing drug. Penalties are up to 10yrs in prison , but not for the mothers. Missouri ? Life Wins !

+On 9 April , Mark Houck won a settlement of \$1.2 million from the US DOJ. It has been 4 years after an FBI raid on his family home. He was charged with violating the FACE Act . He was sued for protecting his

Son outside a PP clinic in Philadelphia in Oct 2021. They were praying when a clinic employee harassed his son and Mark pushed him away. This is a win for ProLife and a precedent for many other cases.

+ On 14 April the DOJ released a 900 page report on Planned Parenthood (PP). How PP fed “targets” for FACE Act suits to his DOJ. The report shows the continuous direct daily email relationship. Most folks don’t know that 4 DOJ prosecutors were fired on 17 April . These lawyers led the Justice Dept Jihad against ProLifers and faith believers. The Report shows how his DOJ supported abortion group interests and requests to pressure ProLife groups/people via bogus FACE Act cases. Atrocious actions . There is hope as AG Todd Blanch has stopped the 2 tiered justice practices against Life.

+On 16 April the 9th Circuit Federal Court ruled against enforcement of an Oregon insurance law. The court ruled that ProLife Organizations do NOT have to provide insurance coverage for abortion. “Government cannot compel organizations to facilitate or subsidize practices that contradict their beliefs

+On 15 April Louisiana House defeated in committee, HB 611. It would have put onerous regulations onto Pregnancy Centers. The La House also passed HCR 28- Prenatal Human Development Education Resolution. The education department must ensure that every student receives education via ultrasound and accurate animation showing development of the conceived baby in the womb. Missouri can easily do this. Message your representative.

+On 20 April the Pennsylvania Commonwealth Court ruled that taxpayers must pay for abortions thru Medicaid claims. “Equal Rights” was the argument PP used.

+In 2022 Indiana passed a law restricting abortions to 10 weeks for rape, 20 weeks for lethal fetal anomalies and danger to the mothers life. On 17 April Indiana AG was granted a motion to have the Indiana Supreme court hear an appeal to overturn a county judge’s permanent injunction to block it. The judge ruled that the Indiana constitution , via religious liberty , provides a “Right to Abortion “ Somehow religious freedom equates to taking the life of an unborn child. Pray for the Indiana Supreme Justices.

+States are passing the Care Act that protects Pregnancy Centers from being forced to perform or refer for abortions. Wyoming, Oklahoma, Montana passed the Act. Kansas passed it and Gov Kelley vetoed it and was promptly overridden. In 2026 ,14 States have introduced anti- pregnancy center referral laws. Missouri ? Pray for our pregnancy center.

LIFE NEWS

+Defunding of Planned Parenthood expires on 5 July. \$832 million per year will again flow to it. Message your representatives!

+On 23 April Senator Josh Hawley filed an amendment to the Senate DHS bill. It extended the defunding of federal funds to abortionists. The amendment was blocked from a vote. Every single democrat voted against it. The house takes up the bill week of 26 April. ProLife groups are pushing congress to include defunding.

+Planned Parenthood now reports killing 1,190 babies every day ! Up 8%

+The British National Health Services now sponsor paid “lunch hour abortions.” “ kill your baby and go back to work.” Is our society headed to this abhorrent practice??

+On 24 April Senator Josh Hawley asked HHS Secretary RFK to stop Title X funding to Beacon Reproductive Health Network, a non-profit in Jeff City, Mo. This entity got \$8 million in federal funding and is known for providing abortion referral. Beacon has the Missouri franchise to distribute Title X funds to 65 health centers, including 7 Planned Parenthood “clinics”. Beacon also refers for gender mutilation of children. RFK said he will work with Sen Hawley to stop the backdoor funding . Who Knew?

+On 24 April Lamar Advertising agreed to put up 14 Abortion Pill Reversal billboards. Lamar initially refused but after legal lobbying by the American Center for Law and Justice, they relented. Lamar owns 363,000 displays. Life Wins !

CHEMICAL ABORTION NEWS

+ Indiana Senator Banks has strongly urged the Federal Trade Commission (FTC) to investigate chemical abortion pill manufacturers and distributors. The issue is continued false and misleading medical and safety claims. Senator Banks pushed the FTC to enforce current federal deceptive trade standards

being violated by the manufacturers and distributors. He noted that the drugs are marketed online as “safer than Tylenol” w/o evidence or studies. Thus deceptive practices misleading consumers. Stay Tuned , We will see if this approach gets traction. Pray.!

+The abortion pill now causes 70% of the abortions in the US. This is from an investigation by Sen. Josh Hawley’s subcommittee. Pray that he gets it pulled from the market.

+Montana Senator Daines urged HHS Secretary Kennedy to reinstate the 2020 FDA safeguards placed on the abortion pill. He pushed for the FDA study to be completed. “Will you implement interim safeguards as well as look at reinstating the in-person dispensing requirement until the safety review is completed?” “Senator , I cant comment on that because of the ongoing litigation.”

+On 1 May the US 5th Appeals Circuit court ruled that mifepristone cant be distributed w/o in person doctor visit. 2 manufacturers sued. Supreme Court Justice Alito delayed the order till 11 May, then delayed till 5pm 14 May. This is huge and will stop majority of telemail pill sales. Pray for Pro- Life result.

+Senator Cassidy of Louisiana has sponsored a bill titled SAVE MOMs and BABIES Act. It will reinstate the FDA Risk Evaluation Strategy . It also brings along the Forced Abortion Accountability Act to impose penalties for coercion to take mifepristone . Senator Cassidy is a leader in eliminating the abortion pill.

+On 27 April CVS denied having the Strategic Relationship claimed by Planned Parenthood. PP then removed that claim from its website. Liars. However, CVS now admits that it fills prescriptions and distributes mifepristone pill sets. For me CVS is an empty parking lot and doesn’t get my business.
