LOCAL NEWS

+On Saturday Sept 12, 2026 after the 4pm mass will be our annual ceremony for the National Day of Remembrance of aborted babies. Join us at our memorial to the unborn.

+The Missouri Catholic Conference has agreed to send speakers to educate us on Amendment 3. We will have a guest speaker on 27 Sept after the 9:15 mass. Please learn more about A3 by attending these seminars.

+Log Cabin Parade- We are entered into the Parade on 3 October at 1045 am. We will display our ProLife Float . We have a new 12 ft ProLife Banner to be carried by some of our youth. Please ride or walk with us to show our ProLife values. We will load up on the road east of the High School at 10am or before.

+We have purchased 100 yard signs advocating VOTE YES ON 3 . Signs are in Henderson Hall .

LEGAL NEWS

+VOTE YES ON AMENDMENT 3 on Nov 3 .

It rescinds the 2024 Amendment 3 which allows for abortions anytime for any reason.

It requires abortion clinics to meet medical standards for Health and Safety.

It insures parental consent for minors before aborting.

It bans gender mutilation for minors.

It reduces public funding for abortions.

It bars fetal organ harvesting .

It requires abortions to be only by a doctor.

+MO AG Hanaway is promoting a statewide tv and radio message on 350 stations warning women about clinics w/no medical standards or license. She urges voters to VOTE YES on 3.

+ On Aug 30 Massachusetts Gov Henley signed into law unlimited abortion thru birth. She professes to be a Catholic. Bishops and laity alike are calling for her to be denied communion or excommunicated from the church . She has stockpiled 15,000 abortion pill kits to kill more babies.

+The 5th Circuit Court of Appeals ruled against Planned Parenthood (PP) appeal to stop a Medicaid fraud lawsuit. The Court sent the case back to the Texas court Judge Kasmayk , who has already rejected PP's claim of innocence. After Texas and Louisiana terminated PP's eligibility to make Medicaid claims in 2015, PP continued billing Medicaid. The appeals are exhausted. The case is now up to the original district court. The fines and penalties add up to \$1.8 to 2 billion owed by PP to the suing states. Pray !

+US Dist Judge Winmill reinstated the Idaho abortion ban in late August. Idaho's Defense of Life Act is back into law. The judge upheld it while a Boise abortionist case against the state plays out. This is unusual in that most judges issue a full statewide injunction whilst the case runs.

LIFE NEWS

+Mckenna West , an Alaska nurse and single mother chose to be a surrogate mother tied to a Calif couple for \$60,000. At 20 weeks a heart issue condition manifested. The parents demanded an abortion . She refused !! The heart condition is treatable by surgery after birth. She moved to Texas for legal protection and world class NICU. Texas AG Paxton got a court order protecting the baby. Baby Gabriel was born and had the surgery. The Calif couple didn't pay her and sued for \$100,000 . Texas law says that if the baby is born in Texas the mother has custody, Stay tuned.

+Canada classifies aborted babies as stillborn not homicide.

+A Quebec doctors group is promoting Euthanasia for newborn babies with disabilities or malformations. Canadian law forbids infant euthanasia as a baby cannot consent.

+ Oakland County of Michigan (Detroit) allocated and distributed \$1.5 million to Planned Parenthood without a vote of the people who objected.

+Every city in the Arkansas county of Lee has passed a ProLife Resolution . They joined 25 other counties and 17 cities in Arkansas.

+ProLife Across America has 10,450 billboards across the US. These mobile digital billboards are on box trucks or vans. The signs show joyful babies before and after birth . ProLife places the trucks at fairs, festivals, concerts, sporting events, graduations, etc. 200,000 people see them every day. They have fone contacts to a 24/7 hotline and local Pregnancy Centers. They have been successful at parking them at Planned Parenthood Centers.

+ Pres Trump has replaced ProChoice FDA Director Makary with ProLife Dr. Heidi Overton. She plans to take chemical abortion drugs off the US market. As expected the Abortionists are in fight mode.

+ Gloria Steinem , a radical abortion advocate passed away at 92 on 3 Sep. Rumor has it that she refused to let the Devil hold the door to hell for her.

CHEMICAL ABORTION NEWS

+Susan B Anthony Pro Life America called on the DOJ to end mail order abortion by settling Louisiana vs FDA. They cited data showing that 81% of online abortion dealers send kits to kill far beyond the FDA 10 week limit . SBA noted that AG Todd Blanche can save 15,000 babies per month by settling the case, taking abortion drugs out of the mail. 83 ProLife groups urged AG Blanche to take action . What is the rest of this story that we don't know about ?

+On 30 August a Fed Dist Judge granted a FDA request for a stay of the suit to revoke national approval of mifepristone until the FDA completes their never ending study of it. The AGs of Texas and Florida cited the Comstock Act in their case petition. Should the AGs prevail , mifepristone will be off the US Market.

+ The AGs of Mo, Texas, and Idaho have asked a Federal judge to restore the FDA's pre 2016 rules of no mifepristone before 7 weeks and 3 in person doctor visits.

+Calif AG Bonta continues suing Heartbeat International as a provider of Abortion Pill Reversal and the operator of the network APRN. He wants Heartbeat to be prohibited from advertising , pay \$20 million for "false advertising " and to block women from using the APR protocol. 200 women used APR in June, 40 from Calif. Go figure. 3 mothers told their story in court of saving their baby. Bonta agreed that zero complaints were ever received. 17 Sept is the date for closing arguments plus 50 days for the judge's ruling (\$\$\$\$) ?

+The US Senate Health Committee has issued a 320 page report on mifepristone manufacturers and failure to oversee distribution and prescription. "Mifepristone Without Guard Rails" exposes a secret system w/o any controls or restrictions. Danco, GenBioPro and Evita do nothing to monitor or report adverse events due to open on line commerce. 28% of US abortions , approximately 300,000 per year are mailed w/o any contact. These drug businesses run rampant and wild. Lets hope that the DOJ and FDA do stop it.
